Eligibility and Procedures:

- 1) Applicant must be an Appraisal Institute Candidate for Designation in good standing pursuing an MAI or SRA designation.
- 2) Applicant must be a member of a Region V Chapter.
- 3) Applicant must have met at least one of the three requirements below:
 - a. Attended two of the applicant's Chapter or Region V meetings prior to receiving a 2023 Region V scholarship award;
 - b. Attended a Chapter or Region Candidate Guidance meeting;
 - c. Recommendation for a Region V Scholarship by a Designated Member (attach recommendation).
- 4) Applicant must submit a completed application to the Region V Executive Director.
- 5) Applicant must submit a 500-word written essay stating why he or she should be awarded the scholarship highlighting professional goals and experience.
- 6) Applicant must submit a resume or statement of qualifications.
- 7) Applicant must submit a list of completed Appraisal Institute courses and designation requirements to date.

Conditions:

- a) Scholarships may only be applied to the advanced courses listed above that are sponsored by Region V Chapters and the Capstone Program, which is sponsored by National.
- b) Scholarship money is for the program fee only.
- c) Scholarships will be equitably awarded on a first come, first served basis.
- d) Scholarship funds will be distributed as follows:
 - a. To the course provider if the course has not yet been held; or
 - b. To the student if the course has been completed, upon receipt of proof of attendance and proof of payment.
- e) No refunds will be given for unused scholarship awards.
- f) Scholarship money must be used in the same calendar year in which it is awarded.
- g) This scholarship does NOT apply toward online courses.
